Thank you for fax messages of yesterday. There are still some outstanding questions regarding my second fax message of July 8, 1992. The museum committee is looking forward to receive from you by fax a final proforma y 15:00 hours today. Please also indicate which bank(s) the credit will be opened at. They are not clear on the fax copies of the proforma. We will place our order today.

What is the minimum number of containers we can purchase, and can the walls be transported without the containers. Please make a reduction on the amount of containers if applicable.

We had dropped the number of the wall panels to 230. Please note this change again and note it on the proforma.

The steering committee has decided on not using any surface foil. Thank you for the kind textile foil offer. Please omit the additional finishing from the proforma.

I would still appeal to you to make a reduction of 5% rather than 4.5%.
